# **Description of the study**

Many children who spend time in the foster care system report experiencing violence, distress, or other forms of traumatic psychological issues as a result of their foster experience. In addition to this immediate trauma, research indicates that in many instances

people involved in the foster care system (i.e. foster children, foster parents, birth children of foster carers) also experience secondary or vicarious trauma through exposure to others' hardships. This study aims to gain a better understanding of these secondary traumatic experiences and their impact on all individuals involved in the fostering process.

This project is led by Professor Damien Riggs, alongside Dr Ben Lohmeyer and Associate Professors Yvonne Clark and Clemence Due. The interviews will be conducted by Shoshana Rosenberg, and all data will be analysed by the research team.

## Purpose of the study

The purpose of this study is to better understand the impacts of primary experiences of trauma and distress within foster care on others within the care environment. This includes how foster care-related trauma affects foster carers, other children living in the home, as well as foster children themselves. By gaining deeper insight into the 'aftershocks' of foster care trauma we aim to develop support mechanisms for foster families which directly address the lingering and at times far-reaching effects of primary as well as secondary trauma.

#### What will I be asked to do?

You are invited to take part in this study as you are someone who is either a current or previous foster carer, a person who has gone through the foster care system, or someone who lived in a foster care environment as a non-fostered child. The study will involve an audio-recorded 90-minute interview which will be conducted over Zoom or Microsoft Teams at a time that is convenient for you. Participation in the interview is voluntary and you may withdraw any time before or during the interview. You will also be given a month-long period following the interview to withdraw.

## **Benefits of Study**

Participants are not expected to directly benefit from the study, however each participant will receive a \$45 voucher as recognition of their time.

#### **Confidentiality and Privacy**

If you choose to participate, your participation will be anonymous to everyone other than yourself and the research team, and all information provided will be treated as strictly confidential. Only the investigators listed on this form will have access to the individual information you provide. An external transcription service will transcribe the audio recorded interviews, but will not have access to any personal information about you recorded in the demographic form. Publications arising from this study will protect your anonymity, including by removing any identifying or personal information.

#### **Data Storage**

Information collected will be stored securely on a password protected computer at Flinders University and on the Flinders University computer server during and after the study. On project completion, all data will be securely stored on the Flinders University computer server for at least five years after publication of the results. Only members of the research team will have access to the transcribed interview data. Following the required data storage

period, all data will be securely destroyed according to university protocols. The only exception to this anonymity is in the case that information is disclosed which indicates a potential risk of harm to a person, in which case the research team is bound by the state's mandatory reporting laws.

## Are there any risks or discomforts if I am involved?

As this study is aimed at gaining an understanding of trauma (both primary and vicarious), there will be topics of discussion which are difficult or potentially triggering, including questions about experiences of violence, abuse, and/or distress. You are not obligated to divulge any information or discuss any topics which you find difficult, and can request to skip a question at any time during the interview. As such, we do ask that you consider whether there is any chance that the study focus might be significantly upsetting for you personally, and if there is any chance that participating may cause excessive or unnecessary distress, to determine whether participation is appropriate for you and your mental wellbeing. If you do choose to participate and subsequently experience feelings of emotional discomfort or distress as a result of participation, the following phone services are available should you wish to speak to someone other than the research team:
